### Project:

The Solid Waste Management Program II – IV (the “Programme”) jointly financed by KfW, the Government of the Republic of Kosovo, and contributions from the European Union addresses critical solid waste infrastructure needs across Kosovo and aims to establish a sustainable and environmentally sound waste management system aligning national practices with EU standards.

The project covers the four administrative regions Pristina, Gjilan, Peja and Prizren, and five infrastructure locations, with a focus on extension of existing landfills, improving landfill infrastructure and closing of one uncontrolled dumpsite.
